

2.E-2005: Establishment of Academic Committees (standing and ad hoc) and Task Forces

1. Purpose

The purpose of this policy is to:

- a) Standardize all academic committees (standing and ad hoc) and task forces with regard to their purpose, responsibility to, composition, chairperson, membership term, policy reference, and listing of current members.
- b) Standardize the procedure to establish academic committees (standing and ad hoc) and task forces.

2. Policy

2.1 Definitions

<u>Academic Committee</u>: a subset of Academic Council members who meet to make decisions or recommendations which pertain to the scholarly activities of the university.

<u>Standing Committee</u>: a committee which meets regularly over the course of the year.

<u>Ad Hoc Committee</u>: a committee which meets as needed for a particular end or case at hand.

<u>Task Force</u>: a temporary group assigned a specific task.

2.2 Guidelines

- a) New committees (standing and ad hoc) will be created by a motion at Academic Council
- b) Task Forces will be established at the discretion of the VP Academic to perform a specific task
- c) New committees (standing and ad hoc) presented to Academic Council for approval will be submitted on the form attached to this policy
- d) Committee members (standing and ad hoc) will be nominated by Academic Council

- e) Task force members will appointed by the Vice-President Academic & Provost
- f) The Vice-President Academic & Provost may serve as an ex-officio member of all standing academic committees as appropriate
- g) Full-time faculty will constitute a plurality on all academic committees (standing and ad hoc) and task forces
- h) Standing committee members will serve a two year term unless otherwise stated
- i) When possible terms should be staggered to ensure committee continuity
- j) Ad hoc committee members will serve their terms for as long as required, subject to recall
- k) Task force members will serve their term until the assigned task is completed
- The work of committees (standing and ad hoc) and task forces will be guided by the relevant academic and institutional policies created pursuant of each committee. Should a policy not exist, the committee (standing and ad hoc) will determine how to guide their roles and if necessary, recommend appropriate policy
- m) All committees and task forces shall elect a chair from among their members
- n) Minutes of all committee and task force meetings shall be taken and posted
- o) The StMU executive secretary will maintain and update the membership list of each committee (standing and ad hoc) and task forces.

3. Procedure

- 3.1 Establishing committees and task forces
 - a) When a need arises for a committee (standing and ad hoc) to be established, interested parties will meet and complete the template attached to this policy and submit to Council for recommendations and approval.
 - b) Upon approval, the interested parties will take the proposed committee (standing and ad hoc) to Academic Council for discussion, further recommendations and final approval.
 - c) Established committees (standing and ad hoc) must review their policies annually and take proposed changes to Academic Council for approval.
 - d) As required, a task force may be established by the VP Academic & Provost who will bring the task force to Academic Council for information.
