## Land Acknowledgment

Since time immemorial, the Children of the Plains, the Siksikaitsitapi – The Blackfoot, have lived in a territory that stretches from the North Saskatchewan River in present day Alberta and Saskatchewan, to the Yellowstone River in the state of Montana, from the Continental Divide in the west, to the Great Sand Hills in the province now known as Saskatchewan. St. Mary's University is located on these traditional territories and in the spirit of Respect, Reciprocity and Truth, we honour and acknowledge Moh'kinsstis, where the Bow River meets the Elbow River; the traditional Blackfoot name of this place which we now call the City of Calgary. St. Mary's University is situated on traditional Treaty 7 territory and oral practices of the Blackfoot Confederacy: Siksika, Kainai, Piikani, Aamskapi-Piikani along with the other signatories of Treaty 7 region in Southern Alberta, the Tsuut'ina Nation and Iyarhe Nakoda Nations: Chiniki, Bearspaw, Goodstoney. We also acknowledge that this territory is home to the Otipemisiwak Métis Government of the Métis Nation within Alberta Districts 5 and 6. Finally, we acknowledge ALL Nations – Indigenous and non – who live, work and play on this land, and who honour and celebrate this territory.

# St. Mary's University

St. Mary's University (St. Mary's) is a dynamic and innovative teaching and research university located on a beautiful historic site that provides affordable, accredited, and highly valued degrees in Liberal Arts, Sciences, and Education. Founded on the Catholic Intellectual Tradition, and as the only independent Catholic university in Western Canada, St. Mary's prepares its students to live with integrity, compassion, and confidence while embodying a compassionate commitment to ethics, social justice, and respect for diversity of opinion and belief. St. Mary's became a proud member of Universities Canada in 2022, and has over 1000 full- and part-time students, approximately 200 full- and part-time faculty and staff, and an average class size of 25.

Located in Mohkínstsis (Calgary) on the ancestral territory of the Blackfoot Confederacy (Siksika, Kainai, and, Piikani First Nations), the Tsuut'ina and Îyârhe Nakoda Nations, as well as the Otipemisiwak Métis government, District 6, Calgary Elbow. St. Mary's is focused on developing the whole person: mind, body, and spirit.

St. Mary's University is committed to fostering an institutional culture that values, supports, and promotes equity, human rights, respect, and accountability within their community. St. Mary's is a university where all are welcome and each unique person is honoured for their inherent dignity. The University is committed to removing barriers for those who have been historically underrepresented or discouraged in society.


The icon complementing the name St. Mary's is based on the letter "M" for Mary. Four qualities of Mary (simplicity, clarity, purity and confidence) are each represented by one of the four letter M's.

The circular arrangement forms a star, a halo of light and strong visual presence well suited to a dynamic, forward-looking institution.

Yellow is the colour of the sun which brings life to all living things.

Blue is the colour of the Virgin Mary. It also represents intellect, peace, contemplation, faith and compassion.
